Minutes of the 4th meeting of the Executive Committee of Mission for Integrated Development of Horticulture (MIDH) held on 29.03.2017 at CR 142, Krishi Bhawan, New Delhi

The fourth meeting of Executive Committee of Mission for Integrated Development of Horticulture was held under the chairmanship of Secretary (AC & FW) on 29.03.2017 at CR 142, Krishi Bhawan. List of participants is at **Annexure**.

The meeting began with Secretary (AC & FW) as Chairman EC welcoming the participants and having a brief introduction with the members of the EC present in the meeting. Leave was granted to the absentee members. After the introduction, Chairman, EC requested JS (MIDH) to proceed with the agenda. JS (MIDH) extended a warm welcome to all the members and apprised them that last meeting of the EC took place on 24.08.2016. Thereafter, JS (MIDH) made a presentation taking up each agenda item. Gist of discussions held/ decisions taken are given hereunder:

Agenda Item No. 1: Confirmation of Minutes of 3rd meeting of EC held on 24.08.2016

1. Confirmation of Minutes:

3rd Meeting of EC was held on 24.08.2016 and the minutes were circulated on 29.08.2016. As no comments were received on the minutes, EC confirmed the minutes of the last meeting.

Agenda Item No. 2: Review of Action Taken on decision/directions given in of 3rd EC Meeting held on 24.08.2016:

Summary details of action taken on the decisions of the 3rd meeting are given below:

Accreditation of Nurseries for production of quality planting material. The accreditation should be made more meaning full so that farmers are aware of the accredited nursery and get maximum benefit on planting material procure from accredited nurseries. There should be a mechanism for tagging/ labelling of planting material obtains form accredited nurseries. The rates of accredited nurseries may be standardized and published. As of now NHB has accredited 1598 Nurseries During 2016-17 NHB has accredited 192 Nurseries. CIH has accredited 22 nurseries till date out of which 19 have been accredited in 2016-17 DCCD has accredited 36 nurseries till date. Mechanism of tagging/labeling of planting material is being done in Uttar Pradesh, Maharashtra, Bihar, Telangana, Tripura, Assam and Haryana. The issue is being pursued with remaining states. Chairman enquired from MD, NHB procedure regarding the accreditation and also enquired from Consultants whether they , while visiting the states, visited accredited nurseries. Agri./Horticulture Commissioner informed the House that very soon codification of tagging would be published. Chairman directed that tagging / labelling of quality planting material should be ensured in all accredited nurseries. NHB should start а special accreditation campaign for nurseries at Kadiyam.

Efforts should be made for both qualitative auantitative and improvement in the accreditation

process.

Officials/ Consultants should visit accredited nurseries ensure that labelling/ tagging is done

meticulously.

monitoring mechanism should be made more stringent so that for states not updating data of progress through portals of MIDH, proportionate made should be in allocation and it may be brought before EC in a midterm for reallocation of funds. Performing states should be rewarded in terms of reallocating funds from states which are not performing.

- Through repeated SHMs have been sensitized upload achievement data timely in NHM/HMNEH portal. Data uploaded by the States are closely analysed for assessing performance the States. of Contradictions Discrepancies. and errors/ omissions are conveyed to the states and reconciled continuously.
- While processing for release of installments of funds, performance of the states is also taken into consideration.

EC noted the information.

JS '(MIDH) informed the House that from this year onwards, for reallocation of funds, interim/midterm review would be done and based upon the performance as reported in the portal, re-allocation will be done

2. Updation correct information on physical financial progress of target achievements from the MIDH website.

Bee keeping activities to be strengthened in states to ensure livelihood for small, marginal, and landless farmers.

Mission Directors to focus more on Bee keeping activities, particularly in SCP and TSP areas.

- Focus is being given more to upscale Bee keeping and explore potential farmers for Bee keeping. RKVY funds are also utilized by several states. Encouragement of Bee keeping activities in SCP/ TSP areas are under taken in Andhra Pradesh, Telangana, Tripura, Kerala, Haryana etc.
- Farmers are sensitized through awareness camps/ events at zonal/ tehsil and district level. Trainings are also been imparted.
- The allocation of National Bee Board has been enhanced from Rs. 5 Cores (2015-16) to Rs. 12 Cores (2016-17)
- While finalizing AAP-2017-18 of states, allocation to bee-keeping component has been enhanced.

Chairman directed to explore the possibilities of up-scaling of beekeeping activities during 2017-18 with an integrated approach.

Review of achievements vis-a-vis targets for physical & financial components.

to in order assess whether through the intervention replanting & rejuvenation. farmers are actually benefitted or otherwise, a rejuvenation intervention should be analysed for assessing their outcome especially in terms productivity improvement. Study/ survey may be conducted to assess the impact and outcome of this intervention in last five years. States should be asked to submit a qualitative report on outcome achieved implementing rejuvenation interventions.

The wholesale Market created under MIDH should be linked with e-NAM by the States.

We should explore the possibility formulation of special schemes for tribal areas. The special scheme may have enhanced cost norm financial assistances and can be dovetailed with the State Government schemes. Other innovation steps should also be explored for optimal utilization of funds allocated for SCP and

- Horticulture Division monitors the progress through portals of MIDH and points out discrepancies in terms of posting of data. Regular interactions (one- to- one as well as telephonic) with SHMs are being done at senior levels.
- Quarterly review meetings—both through VC as well as face to face — are being held in time.
- Review meetings through VC were held on 29.08.2016, 09.09.2016, 16.09.2016, 25.11.2016.
- Face to face review meetings were held on 4-6 April, 2016, 20.10.2016 and 25.10.2016, 09-01-2017 and 06-10 March 2017.
- Next Review Meeting will be held in the first week of April 2017.
- On qualitative report on Rejuvenation, some states like Assam, Telangana, Kerala, Karnataka, Tripura have furnished the report clearly indicating the positive impact on production and productivity.
- For example Telangana has reported increase in yield of 33% and returns to farmers and savings on fertilizers were in the range of Rs. 600-1200/acre.

- In remaining states, surveys are in progress and reports are awaited.
- States have been requested to explore the possibilities for linking wholesale Market created under MIDH with e-NAM
- Implementing agencies have been asked to optimally utilize the funds earmarked for SCP and TSP areas.

Chairman EC directed that Stress should be given on stringent monitoring of implementation of the mission. More and more sensitization of state government officials is necessary.

On rejuvenation, Chairman directed that a crop wise study on rejuvenation should be carried out periodically. Impact on productivity enhancement should be assessed over a period of five years. Success stories on rejuvenation should be shared on MIDH portal.

Shri Satyabrata Mukherjee, member EC, requested that impact of rejuvenation of Mango orchards in Malda, WB may be assessed and highlighted.



Agenda Item No. 3. Review of Financial Progress

JS (MIDH) informed EC that the Division was able to release more than 96 % funds in the Central Sector & nearly 85 % funds in Centrally Sponsored Sector. Some proposals were in the pipeline and with the concurrence of IFD, the Division would be able to release almost 100% funds during the current fiscal. He apprised the EC about the performance regarding fund release under MIDH as also the state-wise release for NHM & HMNEH:

Meeting Held on 24 -08-2016

JS(MIDH) apprised the EC about following activities taken under MIDH after the 3rd EC meeting:

- CCEA approval of Hon'ble PM's Package on Jammu & Kashmir on 27th
 October 2016
- 1st General Council Meeting under the chairmanship of Hon'ble AM on 9th Nov. 2016.
- Periodic review meetings (weekly) with all NLAs.
- Notification on DBT for all schemes of MIDH Feb-March 2017
- Mid-term Review Meeting with NHM/HMNEH States
 - ➤ HMNEH States review meeting held on 20th October 2016
 - ➤ NHM States review meeting held on 25th October 2016
 - > NHM/HMNEH review meeting held on 9th January 2017
- AAP 2017-18 Finalization:
 - Review Meetings with all SHMs for finalization of their AAP during 6-10 March. 17.
 - > Review Meeting with NLAs during 20-24 March 2017 to finalize their AAPs.

Agenda Item No. 6: Special initiative on DBT Mission/Skill Development Programme, PM's special Package for J&K, etc.

Special initiative on DBT Mission

To make the different sub-schemes of MIDH DBT compliant following steps were taken:

 All the implementing agencies – State Horticulture Missions, NLAs, NHB/CDB, CIH were sensitized about the issue and were made aware of the steps required to be taken.

- To facilitate digitization of beneficiary database by the SHM, a data capture application was made available at http://nhm.nic.in and http://tmnehs.gov.in. All the implementing agencies have started digitizing beneficiary data through these weblinks. The digitized data contain Aadhaar and bank account number of the beneficiary.
- A total of 48930 beneficiaries have been digitized till date with a total release of 248.78 crores.
- HORTNET workflow system which is end to end online receiving processing and payment of subsidy request has been launched for MIDH few years back. However, off take of the portal has been sluggish. HORTNET is automatically DBT complaint system. This year through training programmes, hand holding, persistent persuasion more and more states have started using HORTNET.
- A total of 163341 beneficiaries have applied online under HORTNET in the Financial Year 2016-17 with a total disbursement of about Rs. 169 crores directly to the bank accounts of the beneficiaries.
- Aadhaar notification under section 7 of Aadhaar act 2016 has already been issued for central sector scheme of MIDH – NHB, CDB and CIH. Aadhaar notification for centrally sponsored scheme is under process of notification.

EC noted the information.

EC noted the information

PM's special package for Jammu & Kashmir:

- PM's special package for J&K was announced on 7th November 2015 which included Rs. 500 crore towards restoration of damaged horticulture areas and development of horticulture in J&K.
- J&K Govt. submitted its 3 year's Action Plan starting from 2016-17. Rs 124.29 crores
 , Rs 190.73 crore and Rs 184.98 crores respectively for 1st, 2nd and 3rd year.
- The Action Plan was examined vis-à-vis MIDH norms by a Technical Committee headed by Horticulture Commissioner to identify the activities aligned with the MIDH Guidelines and those which would require approval of CCEA for implementation.
- Activities aligned with the MIDH Guidelines totaled Rs.352.71 crore.
- Activities relating to import of High Density Planting material and Four Wire Trellis
 System proposed by the State with financial outlay of Rs.147.29 crore were not
 aligned with MIDH Guidelines.
- For the Non-aligned activities, CABINET COMMITTEE ON ECONOMIC AFFAIRS in its meeting held on 27.10.2016 approved one time relaxation of MIDH cost norms for implementation of PM's Special Package for Jammu & Kashmir towards restoration of damaged horticulture areas and development of horticulture in the state towards import of planting material, import of four wire trellis system and applicability of MIDH



- cost norms for the interventions approved for implementation of PM's Special Package in J & K till 2018-19.
- Administrative approval for implementation of CCEA's decision has been issued on 08/12/2016.
- For the F.Y. 2016-17 out of total requirement of Rs. 124.29 crore, for the activities aligned with the MIDH Guidelines Rs 53.21 Cr (Rs 47.89 Cr Gol Share) has been released to Government of Jammu & Kashmir on 24/08/2016.
- JIT team visited J&K to ascertain the progress at field level and found that due to heavy snowfall in Kashmir Valley in past two months not much progress could be made. However, the State as placed order for supply of high density planting material and trellis system has been erected at few sites.
- The State has spent Rs. 4.40 crore till 31st January, 2017 under the PM's package.

Chairman enquired of the status of implementation of J& K package. JS (MIDH) informed that recently JIT visited the region and found very little progress because of most of the area were under thick snow cover. However, tender/bidding for import of planting material was already done and the same would reach very soon. EC directed that monitoring of implementation may done in close coordination with officials from Govt. of J & K.

Agenda Item No. 7: Steps taken for continuation of MIDH Scheme beyond 31.03.2017.

Appraisal of MIDH scheme

 Impact evaluation study for NHM and HMNEH states was awarded to Institute for Social and Economic Change (ISEC) in November, 2016. ISEC completed the study in time and already presented its main findings and recommendations. Final report is awaited.

Review of cost norms of MIDH

- Five cost norm committees were constituted to revisit the prevailing cost norms for different components of MIDH.
- The reports / recommendations of all the five committees have been received, compiled is under further examination.

Stakeholder consultation

- State and regional level consultations were done during December January.
- Recommendations received have been complied and are being used for modifying operational guidelines of MIDH.

Preparation of EFC Memo

Draft EFC note has been prepared for continuance of MIDH beyond 31st March 2017.

Agenda Item No. 8: Allocation of funds for the year 2017-18 to all implementing agencies

JS (MIDH) informed EC that this year approval from EC is sought well in advance for allocation of resources to implementing agencies for the year 2017-18 so that the cycle of finalizing annual action plan based on allocation and release of 1st installment would be done early. He informed that total outlay of MIDH has been enhanced from Rs. 1660.00 crore (RE 2016-17) to Rs. 2321.47 crore (BE 2017-18) and this was due to enhancement of funds mostly for central sector component (NHB, CDB and CIH).

Allocation under the Central sector component has been enhanced from Rs. 410.00 crore (BE 2016-17) to Rs. 801.47 crore (BE 2017-18) and for Centrally sponsored component (NHM & HMNEH) the increase is from Rs. 1210.00 crore (BE 2016-17) to Rs. 1520.00 crore (BE 2017-18).

The proposed allocation for States/ UTs / NLAs for 2017-18 has been kept at the same level as was in 2016-17.

However, the allocation last year was made after making 10% enhancement in the funds actually available to make provision for spill-over liabilities. Thus, against Rs. 1370 crores for CSS Rs. 1328 crore have been allocated as per the above tentative allocation. Remaining amount may be allocated to some high performing states or may be kept for some unforeseen and urgent interventions.

While allocating to states/implementing agencies, allocation of 2016-17 was communicated as tentative allocation and based on that they were requested to furnish AAP 2017-18. However, a mid-term review would be taken during October, 2017 and based on that re-allocation of funds will be done.

Agenda Item No. 9: Annual action plans for FY 2017-18

AAPs for 2017-18 have been finalized after detailed discussions with SHMs / NLAs broadly keeping in view the following parameters:

- The AAP should cater to the outcomes expected from various activities under NHM.
- States should focus on only few fruits and vegetables, which may result into maximum outcomes in terms of production, productivity, more export, and more processing, leading to increased income of farmers. For each of the crops identified, the availability of planting material of existing as well as new varieties should be prepared.

EC directed that at least 2% of allocation within area expansion should be kept for minor / under-utilized fruits.

- Activities pertaining to planting material such as new nurseries, seed production, seed import, tissue culture lab, seed infrastructure should be planned to meet the planting material requirement as assessed above.
- Based on the availability of planting material and production target, the new area expansion activity should be planned for the focused crops.
- Post harvest management (PHM) activity must be given prominence; <u>at least 35 %</u> of the budget should be earmarked for PHM and Marketing infrastructure.

EC observed that more emphasis should be given in PHM activities. Value addition of horticulture produce is the need of the hour. Projectization should be encouraged.

- JS (MIDH) informed the house that states were requested to give more focus on creation of integrated pack-house, ripening chambers, primary processing and if required, cold storage/CA storage. *In marketing, April Mandi to active FPOs should be the priority*.
- For last few year investment in protected cultivation has been increasing. The same needs a review in view of the majority of farmers in India are small and marginal farmers and they may not get the assistance for protected cultivation. Possibility should be explored to provide support to FPOs for protected cultivation. In any case the percentage allocation to this component should not be more than 20%.

Views of the house was sought for and after much deliberations, *EC directed that allocation in protected cultivation may be maintained at about 25 % of the total outlay.*

• FPO should be given preference in Post Harvest Management, Market linkage activities.

• JS (MIDH) also informed that instructions were issued for taking up one integrated value chain enhancement project for the most important crop/cluster. The project should be based upon the value chain study of the cluster in terms of availability of inputs such as planting material, water, fertilizers and pesticides, production and harvesting practices, soil health testing, post harvest management/on farm storage and value addition, transport and handling, storage and processing, linkage of the cluster to domestic market, processing centres and export hubs shall also be studied. The project shall have twin aim of enhancing each leg of the value chain and involving farmers/farmer's groups in all the legs of the chain. States have been requested to earmark 10% of their budget to such projectisation.

On the basis of the above broad parameters states were asked to prepare their AAP for 2017-18. AAPs of all the SHMs were discussed in detail and were tentatively finalized during the review meetings from 6-10 March, 2017. AAPs of NLAs are being finalized and are expected to be finished in next few days.

EC also desired that allocation to water resources should be kept at minimum as more assistance is available through PMKSY, and other state schemes. However, water sources integrated to area expansion and protected cultivation interventions under MIDH may be allowed.

Based on the deliberations made, suggestions offered, review done on the performances of implementing agencies, the following actionable points/ directions also came out that:

- Ministry of AYUSH may send proposal with justification for support of medicinal plants under MIDH taken as part of multi-tier cropping. The proposal shall be examined in light of MIDH norms for implementation in selected states/ NE region.
- The division should organize One day Horticultural Conference in the line of National Rabi/Kharif Conference inviting all the players in the field of horticulture to discuss the challenges, opportunities and way forward.
- INM/IPM interventions need a re-look. Instead of sourcing INM inputs from private sector, more and more public sector sources should be explored. Effectiveness of the interventions should be assessed.

The meeting concluded with vote of thanks to the chair.
