Accordingly, tentative allocation (GOI share) to all States/ UTs/ NLAs has been worked out with proportionate reduction (annexed).

- 2. All the Implementing Agencies are requested to prepare Action Plan for 2016-17 keeping in view the following:
- a) Formulate a long term plan (for at least 5 years ) giving planned physical and financial targets for major interventions under MIDH.
- b) To analyse the trends of AAP and physical/financial progress of last three years to understand the focus area vis-à-vis directions given during review meetings specially relating to PHM, Area Expansion, Mission Management component.
- c) Suggest measures for effective implementation of MIDH Scheme with special regard to empowerment of small & marginal farmers, women and Skill Development.
- 3. The final allocation will be done at the beginning of FY 2016-17 on the basis of the review of last three years performance, major issues to be addressed, utilization of funds for 2015-16 and the feedback on above points received from the state. The proposed AAP 2016-17 and feedback on above stated points may be sent well in advance before the review meeting to be held during recess of Budget Session of Parliament (March, 2016).
