With the approval of competent authority, it has been decided to re-constitute the Joint Inspection Teams (JIT) comprising of representatives of Horticulture Division, DAC, State Agriculture University/ICAR Institutes and representatives of State Horticulture Missions and SMIC of concerned states, to monitor the implementation of various horticulture development programmes in HMNEH States viz. HMNEH, NMMI, NHB, CDB and National Bamboo Mission during 2015-16. The composition of JIT for various states is as per details at **Annexure**.

The JIT is required to undertake field visits in the states for about a week or more, as appropriate, in 2-3 spells to verify the status of field level activities, as per the approved action plan. The representative of Horticulture Division, DAC will function as team leader of JIT. All the team leaders are requested to undertake the field visit in consultation with the concerned states, other members of the team and submit their report to Horticulture Commissioner immediately after the visit. Team leader may collect the details including a check list of horticulture schemes as above, being implemented in the states before undertaking field visits.

Team leaders are also requested to undertake field visits to monitor the implementation of horticulture development programmes under RKVY in HMNEH states. The details of the scheme may be collected from the RKVY portal viz.www.rkvy.nic.in
