
Sir,

OFFICE MEMORANDUM

Subject: - Mapping of Head of account in Bharatkosh Portal for depositing interest earned by the States & UTs with Legislature from the funds released - regarding.

Reference is invited to Para (3) of M/o Finance, D/o Expenditure OM No. 1(13)/PFMS/FCD/2021 dated 30.06.2021 wherein it is stated that "For Central Government, the amount shall be deposited in the account 0049018000000 (Miscellaneous Interest Receipts) by the States and in 0049028000000 (Miscellaneous Interest Receipts) by the UTs with Legislature".

2. Therefore this office has opened separate Sub-Heads and Detailed Heads below 0049.01.800, 0049.02.800 (with the approval of O/o CGA, M/o Finance) and these heads have been mapped in Bharatkosh Portal with Purpose name "Interest Earned on Central Share in SNA A/C to be Deposited by State in DAC" and Payment type "Interest Earned on Central Share in SNA A/C to be Deposited by (D/o Agriculture) (separate for every states)" for disclosure transparency and reconciliation etc. The States/UTs can deposit interest earned from the fund release against their State/UTs name as visible on BharatKosh Portal. Details of the Heads are as under:-

(I) **For amount to be deposited by the States**

Under Grant No. 900

0049- Interest Receipt (Major Head)
0049.01- Interest from State Government (Sub-Major Head)
0049.01.800- Miscellaneous Interest Receipts (Minor Head)
0049.01.800.08- Interest earned on Central Share in SNA Account deposited by States (Sub-Head)
0049.01.800.08.01- D/o Agriculture & Farmers Welfare (Detailed Head)

(II) **For amount to be deposited by the UTs with Legislature**

Under Grant No. 900

0049- Interest Receipt (Major Head)
0049.02- Interest from UTs with Legislature (Sub-Major Head)
0049.02.800- Miscellaneous Interest Receipts (Minor Head)
0049.02.800.07- Interest earned on Central Share in SNA Account deposited by UTs with Legislature (Sub-Head)
0049.02.800.07.01- D/o Agriculture & Farmers Welfare (Detailed Head)

3. It is also informed that all States/UTs with legislature has to login/register first on BharatKosh Portal (<https://bharatkosh.gov.in>). Thereafter they will be able to see the Purpose for making a payment in Bharatkosh Portal. The concerned States/UTs should choose the payment type with their State/UTs name and also ascertain the correctness of the selected code as mentioned below:-

Controller Code	001-Agriculture
PAO Code	000743
DDO Code	200717

and then proceed further remittance of the amount.

4. For the convenience for registration in BharatKosh Portal, PPT is enclosed herewith showing step by step procedures for the registration and till the payment is made (User Guide for the registration in BharatKosh Portal is also available on NTRP Portal).

5. In view of above, all Programme Divisions of the Department are requested to issue these guidelines to State Government, UTs with legislature so that they are aware about the procedures of remittance of interest of Central Share on SNA account of Centrally Sponsored Schemes (CSS) on "<https://bharatkosh.gov.in>".
