## OFFICE MEMORANDUM

Subject: Retention of old scheme codes against the renamed Centrally Sponsored Schemes of the Financial Year 2022-23 -reg.

M/o Finance, D/o Expenditure vide OM No. 1(13)/PFMS/FCD/2020 dated 23.03.2022 has issued revised procedure for implementation of CSS Schemes, w.e.f. 1<sup>st</sup> July 2021. The new procedure required the opening of SNA account by each State/UTs (with legislature) for each scheme and having separate budget line etc.

2. As per EFC recommendations/DoE, M/o Finance, the Schemes/Sub-Schemes have been rationalized and in the Financial Year 2022-23, and some of the sub schemes of Green Revolution of financial year 2021-22 have been renamed under the umbrella scheme of Krishionnati Yojana in FY 2022-23. The details of the same are as below:

3. Due to the renaming of the above Schemes, under Krishionnati Yojana, separate Scheme Codes were allotted by PFMS (HQ), O/o CGA, N.D. This resulted in non reflection of various reports in PFMS, relating to previous Financial Year i.e. 2021-22.

Keeping in view of the situation the matter was taken up with PFMS (HQ), D/o Expenditure, M/o Finance with the approval of Competent Authority based on reference made by various division and on the basis of discussion held in SOM under the Chairmanship of Secretary (DA&FW) to retain the old schemes codes for the renamed Centrally Sponsored Schemes of 2022-23.

4. Now PFMS (HQ) has accepted the request of this office and had retained the old schemes codes for the aforesaid schemes. All the heads relating to these schemes have been re-mapped by this office in PFMS and the sanctions which have been generated and paid by concerned PAOs during the period 01.04.2022 to 30.05.2022 has also been shifted under the retained schemes codes. Hence, henceforth the under mentioned schemes with respective codes shall prevail in the FY 2022-23.
