Minutes of the Mid-term Review Meeting held on 9th & 11th October, 2017 with States to discuss progress of MIDH Scheme for 2017-18 at Krishi Bhawan, New Delhi

A meeting was held under the chairmanship of Shri Dinesh Kumar, Joint Secretary (MIDH), with SMDs/Senior Officials/representatives of Implementing agencies on 9th & 11th October, 2017 to review the mid-term performance/implementation of the scheme.

List of participants in the meeting is at Annexure-1.

Shri Dinesh Kumar, Joint Secretary & Mission Director (MIDH) welcomed the participants and explained the broad objectives/agenda points of the review meeting.

Initiating the discussion, JS (MIDH) highlighted the issues such as Physical and Financial progress (target vis-à-vis achievement) for 2017-18 along with the progress of spill over activities, issues related to value chain study/DBT/HORTNET/ status of posting/updating data in portals of MIDH.

He urged all the States to speed up implementation by exhausting unspent balance of previous year and first installment of current year. He also urged states to furnish audited Utilization Certificate of 2016-17 accompanying proposal for 2nd Installments. He highlighted the need of the hour to make MIDH scheme 100% DBT compliant by 31.12.2017, since beyond that no further release could be made possible. He also sensitized all participants regarding importance of imparting skill development training as per MSDE's norms. With those opening remarks, he requested SHMs to put forward a brief horticulture profile of the States and the activities done/to be done so far under MIDH.

While reviewing the performance of States, data as reported by them upto 30.09.2017 was taken into consideration. States were requested to strictly adhere to the time line of web based reporting since it is the only way available to assess ground level implementation of the Scheme and based on reports available, NITI Ayog/PMO/Cab Sec are being regularly briefed about the achievement of the scheme.

Consolidated physical and financial progress of participating States is at Annexure-

- 2. Some of the highlights that came up while discussing with SHMs are as under:
 - In Uttar Pradesh, they are planning to increase area covered under banana cultivation from 85,000 ha to 3 lakh hectre in coming years through establishment of TC lab. SMD, UP intimated that in some belts of UP, the outbreak of Panama wilt has been reported, Horticulture Commissioner advised SHM to take the matter seriously and initiate remedial measures. State was requested to promote more and more ripening chamber and Integrated Pack House. SHM, UP has requested for enhancement of allocation as they have already exhausted their available fund.
 - SMD, Chhattisgarh raised the matter of skill development through empanelled Vocational Training Provider as KVKs are not responding well in imparting training. This issue needs to be examined by DC (SK).
 - SHM, Punjab intimated that the third installment of 2016-17 released in March, 2017 by Gol and 1st Installment of 2017-18 released in July 2017 are yet to be received by them. They requested JS (MIDH) to follow up to take the matter at appropriate fora. JS (MIDH) directed to put up D.O. letter from Secretary to Chief Secretary, Punjab on this issue.
 - SHM, Delhi intimated that with the available send request from revalidated funds, they would be soon releasing funds to sanctioned projects.
 - SHM, Arunachal Pradesh was requested to send request for revalidation of funds of 2015-16.
 - SHM, Maharashtra was requested to link CoEs with ASCI, so that the Centres can also impart Skill Training.
 - SHM, Bihar had intimated that due to the delayed release of funds from State Treasury, implementation is very slow. They have appraised the house of special initiatives by signing MoU with BARC for enhancement of shelflife of litchi upto 60 days.
 - SHM, Gujarat has intimated that apart from GoI subsidy, there are top up subsidy available over and above cost norm (15% for General and 25% for ST/SC)
 - SHM, Jharkhand has intimated that due to dependence on contractual staffs the progress of implementation is very slow as the contractual staffs also

leave the mission for better opportunity. As suggested, they were requested to explore possibility of implementing the Scheme through hiring agency and taking manpower through then rather than individual contractual employees.

- SHM, Odisha has intimated that apart from GoI subsidy, there are top up subsidy available of 20% in Protected Cultivation.
- SHM, Goa has requested to release 2nd Installment as they have already furnished audited UC with the proposal.

With these, the following actionable points have been re-iterated by JS (MIDH):

- States will come up with proposal for release of 2nd installment with all the prerequisite documents at the earliest.
- Reply to Audit paras should be timely furnished to Pr .Acc. Office so that same may be dropped.
- Updation of web based report should be timely done.
- Compliance of DBT by 31.12.2017 may be followed up
- Issues relating to Skill Development Training should be addressed to so that the targets could be achieved by 31.03.2018.
- Re-allocation of funds will be considered by EC in next meeting and performing states would be rewarded with enhanced allocation by reducing proportionate allocation from non-performing states.
- A revised format for release of 1st / 2nd installment will be issued which will include progress on HORNET updation, DBT, Skill Training reporting and HAPIS updation and Audit paras.

The meeting ended with Vote of thanks to the Chair.
