
Madam,

I am directed to refer to proposal of Government of Madhya Pradesh for release of 1st installment of funds under MIDH during 2023-24. Since MCC is in effect in the State due to ensuing assembly elections, NOC from Election Commission of India was sought before release of funds. ECI vide letter dated 06.11.2023 (Copy enclosed) allowed released of funds to Government of Madhya Pradesh subject to the following conditions:

- (i) There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.
- (ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- (iii) These restrictions on publicity will be applicable to the Central Government as well as the State Governments concerned.
- (iv) The relevant provisions of Model Code of Conduct issued by the Commission shall be strictly followed.
- (v) No new work shall be taken up afresh during MCC period.

2. Accordingly, this Department has released 1st installment of funds to SHM Madhya Pradesh for Rs. 867.50 lakh under NHM/MIDH for the FY 2023-24 vide this Department's sanction letter of even number dated 7th November 2023 (Copy enclosed). It is, therefore requested to comply the aforementioned conditions while utilizing the funds released under MIDH during the period of imposition of Election Code of Conduct in the State.
